## EXPERIENCE IN FORENSIC PSYCHOLOGY THROUGH 2007

### EVALUATION AND TREATMENT

*Conducting clinical evaluations related to criminal law including competency to stand trial, criminal responsibility, juvenile waiver decisions, and sentencing determinations*

Ψ Has conducted a total of 1,469 criminal forensic psychological evaluations, at least 21 of which were focused on confession issues.

*Conducting clinical evaluations regarding a broad range of civil legal issues including civil commitment, personal injury, and child custody*

Ψ Has conducted 250 psychological evaluations relevant to civil commitment of sex offenders.

Ψ Has conducted 15 comprehensive child custody evaluations.

Ψ Has conducted 338 family evaluations requested by a court, the Department of Children and Families (formerly HRS), the Coalition for Families and Children, and/or the Child Protection Team.

Ψ Has conducted 3 forensic psychological evaluations to assess the extent of damage to psychological functioning following a personal injury.

*Providing specialized treatment services to individuals involved with the legal system*

Ψ Provided an outpatient sex-offender treatment program from 1988 to 2007.

Ψ Provided court-mandated psychological services to individual clients (e.g., as a condition of probation) following charges such as DUI, spouse battery, child abuse.

*Providing consultation and training to law enforcement personnel*

Ψ Psychological consultant to Sarasota Sheriff's Office since 1994: Has provided 1,003 pre-employment evaluations, 30 fitness-for-duty evaluations, and 9 special assignment evaluations; provides focused post-incident intervention; provides on-

site consultation to hostage negotiation team; provides counseling to law enforcement personnel; monitors progress of employees in mandated counseling.

Ψ Psychological consultant to Sarasota Police Department since 1988: Has provided 385 pre-employment evaluations, 17 fitness-for-duty evaluations, and 58 special assignment evaluations; provides focused post-incident intervention; provides counseling to law enforcement personnel.

Ψ Served as external psychological consultant to Manatee County Sheriff's Office from 2003 to 2007. Provided 3 pre-employment evaluations and 7 fitness-for-duty evaluations.

Ψ Has appeared as an expert witness in court 353 times and has testified regarding competency to proceed, sanity at the time of the alleged offense, competency to waive rights, treatment and sentencing considerations, involuntary hospitalization, dangerousness, fitness to parent, ability of the parents to meet the best interests of the child, the psychology of interrogations and confessions and related issues, detection of deception, reliability of child witnesses, civil commitment, and civil commitment of sex offenders.
